

Burning Tree Golf Club -Club Profile

Burning Tree Golf Club established in 1958 is a private country club in Macomb County. Burning Tree features a traditionally designed regulation 18 hole golf course with tree lined fairways and the Clinton River winding its way through. The river comes into play on 6 holes including the 18th hole with its beautiful peninsula green. To ensure the finest playing conditions, the course is meticulously maintained with smooth greens surrounded by white sand bunkers. A fleet of carts and fully paved cart paths service members needs. Walking the course is also enjoyed by many members. This par 71 golf course presents a much greater challenge than its 6140 yards might indicate. Golfers quickly realize that all forms of shot-making and skill are required here!

Other golf amenities include a spacious professional driving range with practice bunkers and two putting greens. The Golf Shop offers the finest equipment and apparel, featuring the most famous names in golf. Our PGA head professional, Mark Johnson, and his staff, are trained custom fitters who can get the right equipment into your hands within a week. The professional staff arranges outings, gives private lessons, coordinates Burning Tree's tournament schedule and oversees an extensive junior program for children ages 8 through 17 years of age during the summer months.

The locker rooms include the upper floor men's locker room completely renovated in 2001. It hosts a 19th hole leisure room providing food and beverage service, lounge area, sauna room, showers and all locker attendant services including shoe cleaning and spike repair. The lower ladies locker room, renovated in 2008, features a game-playing area, sitting area and shower area. Again, a full time locker attendant provides the required services.

The unique clubhouse features a grill room and bar for a casual bite between rounds, as well as a more formal dining area with large picture windows that overlook the beautiful golf course. When weather permits, a spacious outdoor patio offers a relaxed dining experience where diners can sit under the canopy and view the golfers as they play up to the 18th green. During the golfing season, the dining area is open Tuesday through Sunday for breakfast, lunch and dinner. Members and their guests are provided fine quality cuisine and professional, yet very personalized service. The menu is extensive and the chef's daily specials reflect member wishes. Completely renovated in 2020.

Special Arrangements for private parties, wedding receptions, business meetings or Golf Tournaments may be arranged to accommodate the needs of our membership. A competent staff is on hand to assure these functions fully meet member expectations.

APPLICATION FOR MEMBERSHIP PROCESS

1. Completely fill out both sides of the membership application form. Be sure to note the type of membership that you are interested in (family, single or corporate).
2. Your driver's license number and social security number are required and must be verified for accuracy. This information will be kept confidential.
3. Sponsors are not required but if you know any of our members, please make note of their name under the sponsored by line. They will be contacted for personal verification.
4. A valid charge card and bank account information must be kept on file as security for unpaid charges. Club reserves the right to assess past due charges either through ACH debit to member's bank account or by charge to member's on file credit in the event that the account becomes past due.
5. Upon receipt and review of your membership agreement, you will be notified of your acceptance to membership and asked to set up an appointment for picking up your new member packet. An investigative consumer report may be obtained in consideration for membership.
6. An informal interview or briefing of the club rules is required and you will be given your membership number and all pertinent information at this meeting. This is also the time to have all of your questions regarding club rules or policies answered.
7. New member orientation sessions may be held by the Board of Directors and all new members will be required to attend one of the sessions. You will be notified of the dates and asked to make a reservation to attend. If you do not attend an orientation, you will be temporarily suspended from golfing until this requirement is met.
8. Please note that you are applying for a minimum one calendar year membership.

2020 BUDDY PROGRAM AGREEMENT Terms and Conditions

To qualify as a Buddy, an individual must not have been a member of Burning Tree within the past twelve months, on a leave of absence or been previously in the buddy program. You can only qualify for reduced rates on the Buddy Program one time. Sponsors must be current members in good standing. Burning Tree reserves the right to reject any prospective Buddy request in its sole and total discretion.

The Buddy and Sponsor are obligated to dues, annual fees and food and beverage minimums for a period of one calendar year beginning with the first full month of membership. At the conclusion of the twelve month period, the Buddy will automatically convert to a full membership or single.

The first month dues and all annual fees must be paid at time of application. An application for membership (membership agreement) and all attachments including Exhibit D payment provisions, along with the Buddy Agreement must be signed by both the sponsoring member and the Buddy before a membership number is assigned and club privileges are permitted.

The Buddy agrees to abide by all of the Club Rules and By-Laws as set forth in the Handbook of Rules and By-Laws and the terms and provisions of the Member Agreement, including but not limited to all payment authorizations set forth therein.

Dues are billed in advance on a monthly basis with full balance due each month no later than the 25th of the month. If the Buddy resigns or his/her privileges are otherwise terminated by Burning Tree, voluntarily or involuntarily, before the term of the contract is fulfilled, all dues and fees to the end of the contract shall be immediately due and payable and in such event the sponsoring member will return to full dues obligation immediately retroactive to the date of such Buddy termination. For any and all unpaid sums due to Burning Tree at any point in time during the period of the Buddy Agreement and for any period following termination of the Buddy Agreement, Burning Tree shall be authorized to secure payment through procedures set forth in the Membership Agreement including, but not limited to, bank account debit or charge card, without limitation or objection by Buddy.

Sponsoring member agrees and acknowledges that his/her dues reduction set forth above is contingent upon his/her sponsored buddy complying with all financial obligations, timely, for the entire on (1) year term of the Buddy Agreement Period. In the event the sponsored buddy fails to remit any payment during the entire one (1) year term of the Buddy Agreement Period, the sponsoring member shall be responsible to return, or incur additional charges for, any and all dues reduction sums received by sponsoring member during the entire on (1) year term of the Buddy Agreement Period irrespective of the circumstances surrounding the buddy breach. Sponsoring member agrees and acknowledges that he/she is receiving an eligible reduction in member dues for the Buddy Agreement Period in consideration for his/her buddy meeting any and all financial obligations for the entire one (1) year term of the Buddy Agreement Period. Breach of a buddy's responsibilities shall include, but not be limited to, failure of the buddy to remit payment for all financial

obligations to Burning Tree including but no limited to monthly dues, food charges, late fees and interest, which remain unpaid for any period of time subsequent to the date said payments are due, irrespective of whether Buddy's privileges have been terminated or not. Sponsoring member further acknowledges and consents that his/her obligations under the payment provisions of the Buddy Agreement shall exist for the entirety of the Buddy Agreement period and survive the expiration of the same for all periods during which sums are due by Buddy to Burning Tree.

Sponsoring members and their Buddy are not eligible for leave of absence status during the twelve month commitment period.
